# **Student Mobility-International Exchange**

Number of UBC Undergraduate Students going on International Exchange.

In combination with other metrics under Goal 1, to assess the capacity for UBC undergraduate students to engage in interntional exchanges.

PAST REPORTING: Go Global Program: UBC Student Safety Abroad Trave Registry. Includes Co-op, field study, internships, educational practicum, international projects, letters of permission, research not otherwise indicated in previous categories, nursing clinical placements, student teams and conferences. Does not include inbound exchange students; reporting only on UBC student participation outbound. May 1 to April 30 (Academic Year)

## **International Service Learning**

### Number of UBC Undergraduate Students Participating in International Service Learning

In combination with other metrics under Goal 1, to assess the capacity for UBC undergraduate students to engage in interntional activity.

UBC supports international development efforts through international service learning programs offered by UBC's Centre for Community Engaged Learning. Students are engaged in international placements that support development projects, while also providing learning opportunities for students. Priority projects are identified by community partner organizations and are jointly scoped with the organization, UBC staff and faculty. While international organizations are no longer explicitly referencing the Millennium Development Goals (MDG), projects continue to link into development goals at international, national, regional and local levels.

Projects addressing poverty reduction, universal primary education, reduction of mother and child mortality, and clean water and sanitation, remain relevant with most projects fitting within this framework. Students engage alongside and under supervision of organization staff.

Over the past year, students were involved in ISL initiatives in the following countries: Uganda, Kenya, Swaziland, South Africa, Mexico, Bolivia and Costa Rica. The partners within each country ranged from grassroots to national organizations. Furthermore, the ISL program has formally partnered with the new International Nutrition major in the Faculty of Land and Food Systems to provide pre-departure preparation and re-integration support to students. Students in this major were involved in projects in Cameroon and Sierra Leone.

In addition to supporting the International Nutrition major, partnerships have also been formed to support the Sauder Africa Initiative as well as a number of Bachelor of Education enhanced practicum placements. This expanded realm of support provides opportunity to enhance long-term, iterative and interdisciplinary collaborations with international organizations while providing a robust and holistic learning curriculum for student participants.

In addition to the work supported through the UBC-CCEL, many Faculties, instructors, students, and staff are engaged in international development efforts not captured in the accompanying data. Reference is made below to undertaking actions that will enable that data to be captured most effectively so the activity across the University can be highlighted.

**Next Steps:** In the coming year, the Centre for Community Engaged Learning will seek to understand how else to deploy operational resources to support Faculties, instructors and programs with the design and implementation of international community based learning activity that aims to meet the goals and targets of the institution and the Faculty.

We will monitor these results each year, and the programs related to these metrics in strengthening our efforts to supporting student reaching their full potential.

## **International Learning Experiences**

# **Strategic Partnerships**

To track the total number of formal partnerships with strategic international partners, in which UBC is engaged. In combination with other metrics under Goal 1, to assess the degree of international engagement of UBC as an institution with other similar institutions.

**Number of Formal Strategic Partnerships: 15** 

A strategic partnership is a relationship with a peer international institution or organization that confers an advantage to UBC as a whole by providing access to talent, resources and increased reputation in order to advance the research and teaching mission of our university.

A strategic partnership encompasses most, if not all, of the following activities: (a) robust research collaborations across disciplines; (b) mobility of undergraduate and graduate students; (c) dual or joint awarding of degrees; and (d) mobility of faculty.

## **International Visitors or Delegations**

Number of international visitors or delegations from existing partners, diplomatic corps, and other.

To track the intensity of internatinal visits and/or delegations to UBC, to understand the insitution's engagement internationally. In combination with other metrics under Goal 1, to measure the degree to which UBC engages as an institution with other countries and organizations.

#### **International Alumni**

UBC has over 18,000 international alumni in 93 different countries. They are leaders in industry, government, and their own communities.
